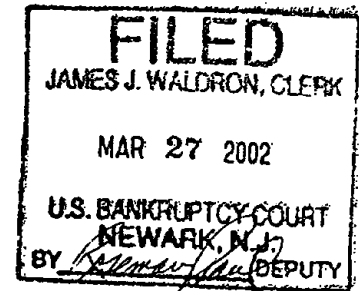

**ORDER EXEMPTING CHAPTER 7 PANEL TRUSTEES
FROM ELECTRONIC PUBLIC ACCESS FEES**

Whereas, the Bankruptcy Court Schedule of Fees issued in accordance with 28 U.S.C. section 1930(b) provides that the Court may exempt persons or classes of persons from a fee for electronic access to court data, and this Court has determined that waiver of said fees for Chapter 7 Panel Trustees of this District would accommodate the April 1, 2002 implementation date ("implementation date") of the electronic case filing system ("ECFS") in this Court, and the mandatory participation of Chapter 7 Panel Trustees in same;

IT IS, on this 27th Day of March 2002;

ORDERED THAT the Chapter 7 Panel Trustees of this District (annexed as *Exhibit A*) are hereby granted an exemption from fees for electronic access to court data until further notice.
