The Local Rules of the Bankruptcy Court for the District of New Jersey, as published, supersede all previously entered General Orders concerning court policy governed by Local Rule. For ease of reference, the following link may be accessed to review the Local Rules.

As part of the analysis, the court has also undertaken a review of the Local Forms included in the Rules. **Under D.N.J. ADJOURNMENTS

Under Local Rule 5071-1. *Adjournment*, a party seeking an adjournment of a hearing in a chapter 7 or 11 case must submit Local Form, *Adjournment Request* to the judge's chambers email box not later than 3 days before the hearing date.

A party seeking an adjournment in a chapter 13 case must submit Local Form, *Adjournment Request for Chapter 13* to the chapter 13 trustee.

If cause exists for the court or trustee to grant an adjournment less than 3 days before a hearing, the resulting date will be a peremptory date, with no further adjournment of that hearing permitted.

"NOTICES OF INFORMATION"

The following forms have been substantially revised, as has their processing. The new forms and process became effective Monday, August 31, 2015.

- Notice of Proposed Abandonment
- Notice of Proposed Private Sale
- Notice of Proposed Public Sale
- Notice of Proposed Compromise or Settlement of Controversy

In addition to revising the form, we are also implementing a new procedure for processing the notices. Specifically, we will be sending out an exact copy of the Notice submitted by the filer. As a result, it will be very important that all information contained in the form is accurate, particularly the hearing date, time and location. The clerk's office has been instructed to stop processing of the notice and to enter a correction notice when any of the hearing information is incorrect. If a filer receives a correction notice they should revise the information in the notice and refile it.

The following **new events** are available for use when filing the new Notices. The events are located in the Misc. Events (or Trustee Events) category.

- Notice of Proposed Abandonment
- Notice of Proposed Private Sale
- Notice of Proposed Public Sale
- Notice of Proposed Compromise or Settlement of Controversy

Other important things to know about the filing of the Notices:

- To allow enough time for processing and receipt of the notice, the hearing dates must be at least 28 from the date of the filing of the notice.
- The deadline to file objections to the Notice will automatically be set for 7 days prior to the hearing date in the event.
- A Notice of Proposed Public Sale or Private Sale must be filled in conjunction with a
 Motion to Sell <u>unless the motion is being heard on shortened time</u>. The motion must
 have the same hearing date as the Notice.
- When a movant does not simultaneously file a Notice of Proposed Private or Public Sale and a Motion to Sell in accordance with D.N.J. LBR 6004-1, the document filed will not be processed. The clerk's office will enter a correction notice indicating that the Motion and Notice of Proposed Public or Private Sale must be filed simultaneously.
- If you create the Notice in MS Word, it must be converted to PDF format prior to filing.

NEW or MODIFIED CM/ECF EVENTS

Motion for Administrative Fee Order - This new event should be used by chapter 11 debtors when seeking authorization for allowance of compensation of professional persons on a monthly basis.

Status Change Form - This new event should be used by efilers when filing local form, *Status Change Form* to report the settlement or withdrawal of a motion.

Chapter 11 Combined Plan and Disclosure Statement – Formerly the *Ch 11 Combined Small Business Plan and Disclosure Statement* event. It may now be used by attorneys for individual AND small business debtors when filing a combined plan and disclosure statement.

Notice of Proposed Compromise of Settlement of Controversy - See above.
